2 Minutes of previous meeting

Minutes of the 2012 Annual General Meeting held on 22 November 2012 were tabled.

Motion: that the 2012 AGM minutes be accepted

Moved – Wendy Merritt; Seconded – Tony Jakeman. Accepted

3 President's Report

The President, Tony Jakeman, gave a verbal report, with the following main points:

- The Society's (informal) journal, Environmental Modelling and Software, no longer uses Special Issues for publishing selected conference papers. Members were invited to consider putting in proposals on Thematic Issues and/or position papers. Tony thanked members for their generosity in reviewing and supporting the journal
- The expansion of the conference to include DORS (Operations Research) and DSTO (defence) has increased numbers and deepened the science and technical coverage – a successful joint venture!
- MODSIM 2015 – we have been talking to the Darwin Convention Centre. Some cons are that we won't easily get government support (as we don't have a strong presence in the NT), and the DCC can only run 8 parallel sessions, limiting number of delegates to ~750.
Tony Weber suggested Brisbane and will follow up. Sue suggested Alice Springs and will follow it up, as well as other ideas for the NT.

4 Treasurer's Report

The Treasurer, Wendy Merritt, tabled the 2012/13 financial year statements.

- The Society continues to be in a sound financial position, with a bank balance of \$260,993.88 @ 30 June 2013, with just over 60% of that invested in the Society's Sinking Fund.
- The 2012-13 financial year saw an operating loss of \$34,778.51, due to MODSIM2013 upfront expenses. This will be more than offset by MODSIM2013 registrations which will be reflected in the 2013-14 financial year, with MODSIM2013 set to make a good return.

The Treasurer gave a verbal report

- Running the MSSANZ ‘office’ cost ~\$25K (mainly related to resources spent in moving the Society’s website and OCS to a new host, and in programming OCS), which has been absorbed by the iCAM office. Properly accounting for these expenses is essential and needs to be part of budgeting for the office.
- Tony Dekker suggested putting together an OCS User Committee, which would complement the current Technical Committee.

• ACTION: Secretary to ensure that User and Technical Committees are set up with their main focus being on the running of the congress registration and review software (currently using OCS).

6 Adoption of new rules

The Secretary spoke to the (proposed) new Constitution (Rules) which were made available to members with notice of AGM. The Constitution has been rewritten to be compliant with the (Victorian) Associations Reform Act 2012, and to incorporate the role of the MSSANZ ‘Office’. Due to the number of changes, the new rules were put to the AGM as one motion.

“that the MSSANZ Constitution (Rules) as tabled (and amended) at this 2013 Annual General Meeting be adopted”.

8 MODSIM 2013 report

Convenor, Julia Piantadosi, provided a verbal report. Some statistics of interest:

- # papers – 514
- # extended abstracts – 290
- # delegates – 809
- # countries - 32
- # Sessions – 82

The relationship with the Adelaide Convention Centre has worked well, as have those with our congress partners, ASOR (the Australian Society for Operations Research) and DORS (the DSTO led Defence Operations Research Symposium).

The trial of U-sessions (united sessions) was partially successful (U-sessions being cross-stream sessions/papers that bring together multiple disciplinary threads).

10 General business

10.1 Society policies

Part of transiting the Society to a modern governance structure is the capturing of many of its (unwritten) operating principles in Policies, which are equivalent to By-Laws in their management (ref Clause 72 in the proposed new Rules).

10.1.1 GUIDELINES FOR CREATION AND MANAGEMENT OF SOCIETY AWARDS

Roger Braddock, Fellow and 2007 Biennial Medallist, spoke to draft guidelines for the creation and management of Society Awards, and the constitution of the Awards Committee, the role of that Committee being to advise the Executive as to types of awards, and recommend on award recipients. The discussion that followed centred on how that Committee should be constituted, as it has previously been selected by the President, and chaired by the President. The meeting felt that it was appropriate that the Committee not be chaired by the President, but made recommendations to the President (and the Executive). It was further proposed that the process for determining membership of that Committee be contained within the Constitution to ensure the transparency of the process, and the following amendment included as part of the earlier motion to accept the revised Constitution (as amended).

The two motions that had been put on notice were put to the members:


