#### 10.5 Potential joint conference with the Winter Simulation Society

- (David Post) The Winter Simulation Society is interested in running a joint conference with MODSIM in 2029
- Current idea is for both conferences to run concurrently at the same venue, with registration for either conference allowing attendance at both; has advantage of sharing some costs

#### 10.6 Open Modeling Foundation (OMF)

- (Takuya Iwanaga) MSSANZ is now a member of the Open Modeling Foundation (OMF), an international meta-organisation an organisation of organisations that work to coordinate and administer a common community developed body of standards and best practices to enable the next generation of modeling of human and natural systems.
- They do this across a few working groups, pertinent ones including
- Standards Working Group Developing standards for code/data access, documentation, reusability, and interoperability
- Certification Working Group Develops and administers programs to certify model code that meets OMF standards for modeling best practices
- Education and Outreach Working Group Developing material to train next generation scholars and ensure proactive outreach to groups and nationalities that are underrepresented in modeling science
- Early Career Scholars Working Group Aiming at encouraging involvement and discussion around open modeling issues which early career scholars (or researchers) face.
